Estimated Long-Term Mutual Fund Flows

Washington, DC; May 6, 2026—Total estimated outflows from long-term mutual funds¹ were \$16.84 billion for the week ended Wednesday, April 29, the Investment Company Institute reported today. These outflows represent 0.1 percent of long-term mutual fund assets as of March 31. Estimates for combined long-term flows and ETF net issuance are available on the [ICI website](#).

Equity funds² had estimated outflows of \$24.08 billion for the week (0.2 percent of March

31 assets), compared to estimated outflows of \$18.91 billion in the previous week. Domestic equity funds had estimated outflows of \$22.18 billion (0.2 percent), and world equity funds had estimated outflows of \$1.90 billion (0.1 percent).

Hybrid funds²—which can invest in stocks and fixed-income securities—had estimated outflows of \$1.25 billion for the week (0.1 percent of March 31 assets), compared to estimated outflows of \$978 million in the previous week.

Bond funds² had estimated inflows of \$8.48 billion for the week (0.2 percent of March 31 assets), compared to estimated inflows of \$9.34 billion during the previous week. Taxable bond funds saw estimated inflows of \$7.12 billion (0.2 percent), and municipal bond funds had estimated inflows of \$1.36 billion (0.2 percent).

Notes: Weekly cash flows are estimated, while actual net new cash flows are collected on a monthly basis and are reported in ICI's "Trends in Mutual Fund Investing"; therefore, there are differences between these weekly estimates and the monthly flows.
