Girls Who Invest is a nonprofit organization dedicated to increasing gender diversity and inclusion in investment management with a focus on growing the pipeline of women in frontline investing positions. They accomplish this through education, mentoring, internships, and a supportive community. The organization’s flagship summer program enables college students to explore investment management careers through four weeks of free educational training with top university professors followed by a six-week paid internship at one of more than 100 leading investment management firms in the United States, United Kingdom, and Canada. In addition, all scholars receive support and career guidance from a community of partners, mentors, and alumni.
